Georgina Centre for Arts and Culture September 18, 2023 | AGM Meeting Minutes

Welcome and Call to Order: By Linda Lyons, 7:05pm

Additions to the Agenda: No changes.

Approval of the Agenda:

Moved by Widit McLean, Seconded by Debra Ceresne. All in favour. Motion Carries.

Approval of Minutes from September 19, 2022:

Moved by Tom Zsolt, Seconded by Widit McLean. All in favour. Motion Carries.

Welcome and Opening Remarks:

As presented in AGM package.

Message from the Executive Director:

As presented in AGM package with an additional focus on the excellent work and programming put on by our artistic director Charlotte Hale.

Reports:

Financials:

Treasurer's Report High Level Notes:

As presented in the AGM package with the additional key callouts and takeaways:

- GCAC secured a grant for 90k from Central County Tourism.
- GCAC switched auditor due to rise in cost. We are now working with Clarkson Rouble LLP
- Labour costs were down in 2022 due to shortages and changes.
- Most of the GCAC revenue comes through grant funding, 110k from Town of Georgina, 20k from Ontario Small Business Grant, 2 Ontario Trillium Grants. Our grants remain stable and consistent year over year.
- Camps were unable to run in 2022 due to COVID-19, causing a loss in revenue.
- Revenues were down approximately 10k year over year, mainly driven by camp revenue lost.

Question Widit McLean: "What's included under professional fees?"

Answer Meaghan McKinzey: Auditing fees, legal fees and various financial fees.

Rebuttal Widit McLean: "Where are expenses related to classes and camp fees? What was the net revenue of these? This is important to know and to understand if classes are worthwhile or not.

Response Board: Board will take this back as a recommendation.

Treasurer's Report High Level Notes cont.:

As presented in the AGM package with the additional key callouts and takeaways:

- CEBA loan will continue to be repaid by the end of 2023.
- Increase in deferred revenue remains higher due to being unable to spend grants.
- Loan withdraw from Town of Georgina in 2016 for continues to be paid down, over the course of 10 years.
- Excess of \$4500 in revenue for the year, in contrast to \$40k from year prior (due to loans and subsidies from COVID related). \$4500 is to be expected.

Auditor's Report

- Presented by Clarkson Rouble LLP
- Audit was done electronically, but no issues were encountered.
- Substantive approach was taken during audit.
- Testing and controls were not taken due to size of the organization.
- Nothing came to Clarkson Rouble's attention that required follow up.
- Nothing significant to mention in statements.
- Financial statement structure was revisited to be clear and remove schedules that were irrelevant.

Motion:

Tom Zsolt moved a motion to accept the 2022 financials as presented. Seconded by Widit McLean, All in favour, Motion Carries.

Motion:

Ron Lacombe moved a motion to appoint Clarkson Roubel LLP as the auditor for GCAC for the next fiscal cycle. Seconded by Bill Major. All in favour. Motion Carries.

Board Report

- Thanks to members Brian Gibbs, Anita David and Bill Majors for their dedication as they left the board in the last cycle.
- We welcome new members Madalyn Calzavara and Susan Day.

Widit McLean moved a motion to accept the board slate as presented. Seconded by Debra Deresne. All in favour. Motion Carries.

The GCAC positions our town as more than sports and recreation. The work the GCAC does promotes the other side of Georgina and showcases our community and it's broad depth of culture and arts.

Board recommends moving the AGM within the first 6 months due to grant funding and requests.

Sheila Dobson: Wanted to note that she participated in the Old Fox Woman dedication event, and it was the most amazing thing to see everyone come together (students, business owners, etc.). Kudos to the community and GCAC.
